Sub: B.I.E.A.P., Tadepalli, Guntur- Notification for extension of Provisional Affiliation and sanction of additional sections in Andhra Pradesh State for the Academic year 2022-23. Applications are invited from the managements of existing Private Aided / Unaided Jr. Colleges (including composite colleges) / Co-operative / Incentive / A.P. Social Welfare / A.P. Tribal Welfare / A.P. Residential Junior Colleges / Kendriya Vidyalayas - Communicated -Reg.

All the Regional Inspection Officers, Board of Intermediate Education, Andhra Pradesh are hereby informed to intimate all the Principals & Managements of existing Private Aided / Unaided (including Co-op.) / Incentive / APSWR / APTWR / APRJC / Kendriya Vidyalayas in their jurisdiction that they should submit online applications with an option to the Managements to apply for a minimum period of two years and maximum period of Five years for extension of provisional affiliation and sanction of Additional Sections will be available in the website <https://bie.ap.gov.in> from 16-05-2022 onwards. "Even though the College Managements pay the affiliation fee for a minimum period of 2 years and maximum period of 5 years, if the rates enhanced at any point in the five year block period, the revised rates also need to be paid by the college Managements along application fee."

"In this regard, for this Academic year the previous fee may be collected and the affiliation may be given for a block period of 5 years i.e., 2022-23 to 2026-27 subject to payment of revised fees at any point in five year block period."

Further the Regional Inspection Officers are also instructed to issue a circular and give wide publicity for the submission of affiliation proposals in time with all the required documents through online. For sanction of P.A. every year through online all the college Managements are directed to upload the details with valid documents every year.

The RIO's are instructed to inform all the Principals that they should not open new sections without the prior sanction from the Secretary, BIE, A.P. Vijayawada. Any such deviation will be viewed seriously, which will make them liable for disaffiliation besides imposition of penalty under A.P. Education Act -1982 and the rules made there under. Also instruct all the Principals / Managements not to submit the manual proposals directly to Head Office. Such proposals will be rejected.

The last date for submission of on-line applications is 13/06/2022. Few modifications in the process of renewal of affiliation are brought to the notice of the managements of the colleges as follows:

- BIE will issue notification for extension of Affiliations and sanction of additional sections to the Junior Colleges in the State and enable the provision of application to the colleges in bie.ap.gov.in website.
- The college managements will apply in the prescribed form uploading the Required Documents.
- BIE Staff/Officers will scrutinise the applications received from the managements forwarded by them.
- The Colleges which are processed clearance in the Preliminary Scrutiny of JS (Academic), transmitted to RIO login for their specific remarks and inspections will be conducted wherever necessary.
- The inspection reports received from the RIOs will be taken for final scrutiny by the BIE Superintendents and BIE officials.
- In this regard, inspection of all the Colleges was already completed during the months of March & April of 2022 by Three man committee in all districts & the same will be forwarded by the RIO concerned with observations & recommendations to the board which will be taken for final scrutiny and accordingly will accept or reject the application.
- Then only the payment of affiliation fee option will be enabled for those colleges which satisfy all the norms of BIE, AP in this regard.
- The Head Office will then process the file for sanction of affiliation & additional sections and issue admission login for the a/y 2022-23.

The fee rates along with application fee of Rs.500/- are furnished here under:

The RIOs are directed to instruct the managements to upload the prescribed data through online and Geo-tagging images for extension of Provisional Affiliation/sanction of Additional Sections from the official website (<https://bie.ap.gov.in>) of Andhra Pradesh Board of Intermediate Education with effect from 16-05-2022.

The College Managements who have not paid the affiliation fee in the previous years are permitted with a penalty of ₹40,000/- (Rupees forty thousand only) per year in addition to affiliation fees and they can upload their details through online.

The RIO's are directed to instruct the managements to submit affiliation proposals through online only. Any manual proposal submitted directly to the head office will be summarily rejected.
