Sub: B.I.E – Vocational - Academic – Extension of provisional affiliation and sanction of Additional/New Courses for the academic year 2022-23 – Online applications are invited from the colleges imparting Vocational Courses in the State of Andhra Pradesh – Intimation to all the RIO's in their Jurisdiction – Reg.

All the Regional Inspection Officers, Board of Intermediate Education, Andhra Pradesh are hereby informed to intimate all the Principals & Managements of existing Vocational Junior colleges/ Junior Colleges having Vocational Courses and the **existing General Junior Colleges for Opening of Voc. Courses** for the academic year 2022-23 are permitted to submit proposals in **on-line** only for a period of one year only. Further, the Regional Inspection Officers are also requested to issue a circular and give wide publicity for the submission of affiliation proposals in time with all the required documents.

Further, the RIOs are instructed to inform all the Principals that they should not open new courses without the prior sanction from the Secretary, BIE, A.P., Tadepalli, Guntur. Any such deviation will be viewed seriously, which will make them liable for disaffiliation besides imposition of penalty as the rules. Also instruct all the Principals / Managements not to submit the proposals directly to BIEAP, Tadepalli, Guntur. Such proposals will be rejected. **Online admissions for Additional/New Courses will be allowed after getting permission order from BIE only, without permission the colleges will not be allowed for admission of candidates into Jnanabhumi portal.**

The online application form for extension of Provisional Affiliation including sanction of Additional Sections are available in <https://bie.ap.gov.in> up to 13-6-2022 and managements can use login with their college code (user id and password is the same). The managements should invariably fill up all the fields of the application and upload the required documents. The B.I.E. should verify all the applications forms with Geo-tagging images/locations thoroughly with regard to RCC accommodation, additional accommodation for Additional Sections/Courses, valid FDR, Registered Lease Deed of building & Playground, Approved building plan, valid Fire Safety Certificate, Sanitary, Structural Soundness Certificates, NOCs from competent authorities, Parking area, qualified employees details etc., as per norms before sanction of the provisional affiliation/additional sections through on-line for the academic year 2022-23. The RIOs concerned are requested to submit a consolidated lists of proposals applied for extension of affiliation and sanction of additional/new Courses separately with the list of non-functioning colleges.

The last date for submission of on-line applications is ²⁰13-06-2022. The payment of affiliation fees and inspection fee for additional courses will be made in the next level.



Affiliation fee : Rs.2,000/- per Course/Section.
Application cost: Rs. 200/-

The RIOs are directed to instruct the managements to submit the proposals for Provisional Affiliation and sanction of Additional Sections/New Courses through online only. Any manual proposal submitted directly to the head office will be summarily rejected.
